(He was a Khilafati worker of Kiyamari and due to taking part in the Non-Cooperation Movement he was sentenced to 12 months imprisonment in 1923.)

Abdul Rahim

(He was a Khilafati local leader of the Hyderabad district and in 1922 on account of taking part in the Non-Cooperation Movement he was sentenced to 12 months imprisonment.)

Abdul Karim

(He was a Khilafati worker of Karachi and in 1922 on

account of taking part in the Non-Cooperation Movement he was sentenced to 12 months imprisonment.)

Alauddin

(He was a Khilafati worker of the District Hyderabad and In 1922 on account of taking part in the Non-Cooperation Movement he was sentenced to imprisonment.)

Ali Muhammad

(He was a Khilafati worker of Karachi and on account of taking part in the Non-Cooperation Movement he was sentenced to 6 months in 1922 & 6 months in 1923 imprisonment.)

Ghulam Nabi Qureshi

(He was Khilafati worker of Larkano and on account participating in the Non-Cooperation Movement he was awarded punishment but tendered apology.)

Ghulam Muhammad

(He was a Khilafati worker of Karachi and on account of participating in the Non-Cooperation Movement he was sentenced to 18 months imprisonment in 1922.)

Ramchand Bhojraj Motwani

(Editor Weekly "Azadi" Larkano was sentenced to two Month's imprisonment in 1923 on account of making his Paper an organ of "Non-Cooperation movement")

Pirbhdas Sakhawatrai Tolani

(Editor Weekly "Azadi" Larkano was asked & directed By the Government to deposit security of Rs 1000 Under Section 3 of Indian Press Act in 1932 for publishing objectionable material.)

Khem Chand Balani

(Local Congress leader of Nawabshah & Editor of

The "Shakti". In January 1922 he was sentenced to imprisonment for one year on account of publishing Poetry against the Rulers in issue of December 28, 1921 Of his Newspaper.)

Himandas Shewakram

(Local Congress Leader of Nawabshah & Editor of "Shakti". He was sentenced to imprisonment in October 1922 under Section 24-A.)

Gurmukhdas Tejomal

(Local Congress leader & the editor of "Shakti". He was sentenced to six months imprisonment in 1923.)

Mansingh

(Local Congress leader & the editor of the "Shakti". He was sentenced to two months imprisonment in 1923.)

Ramchand Veromal

(The editor of the "Qurbai" of Shikarpur. He was asked the security of Rs 3000 in July 1937.)

Tharyomal

(He was a Congress worker of Dadu, and was sentenced to 11 "Samachar" of Nawabshah. On account of publishing an objectionable material on the "Independence Day" celebrated by the Congress in 1945.)

Tilokchand Gopaldas

(He was a Congress worker and the editor of the "Hind Samachar", Nawabshah. In 1945 he was convicted and remanded to Jail custody for political offence of publishing an "Independence Day issue".)

Pandit Ganga Shankar

(He was a Congress worker of the Tharparkar district. In 1922. He was sentenced to 12 months imprisonment on

account of participating in the Non-Cooperation Movement.)

Pinyo

(He was a Congress worker of Badin and was sentenced to imprisonment due to political activities in 1928.)

Jhamatmal Lakhasing

(He was a Congress worker of Hyderabad and was sentenced to 12 months imprisonment in 1923.)

Haji Pir Bux

(He was a worker of the Khilafat Committee of the Hyderabad District and was sentenced to 12 months imprisonment in 1922 on account of taking part in the Non-Cooperation Movement.)

Haji Karamullah

(He was a worker of the Khilafat Committee of the Hyderabad District and was sentenced to 3 months imprisonment in 1922 due to his participation in the Non-Cooperation Movement.)

Hakim Shah

(He was a Khilafati worker of village Gaji Khuhawar and was sentenced to 12 months imprisonment in 1922 on account of taking part in the Non-Cooperation Movement.)

Hakim Qaimuddin

(He was a Khilafati worker of Jacobabad and in 1922 due to taking part in the Non-Cooperation Movement he was sentenced to 6 months imprisonment.)

Hakim Muhammad Muaz

(He was a leader of the Khilafat Committee of the District Nawabshah and in 1922 due to taking part in the Non-

Cooperation Movement he was sentenced to 12 months imprisonment.)

Dr.Menghraj

(He was a Congress leader of Jacobabad and due to taking part in the Non-Cooperation Movement he was sentenced to one month's [in 1922] and six months [in 1923] imprisonment.

Radha Kirshin

(He was a Congress local leader of Jacobabad and due to taking part in the Non-Cooperation Movement he was sentenced to one month [in 1922] and six months [in 1923] imprisonment.)

Raman Bai

(She was a Congress worker of Karachi and in 1932 she was sentenced to 3 months imprisonment.)

(He was a local leader of Karachi Congress and in 1921 due to participation in the Non-Cooperation Movement he was sentenced to 12 months imprisonment.)

(He was a Khilafati worker of Karachi and in 1922 due to his participation in the Non-Cooperation Movement he was sentenced to 12 months imprisonment.)

Kishindas Kanyalal

(He was a Congress worker of Shikarpur and in 1922 due to his participation in the Non-Cooperation Movement he was sentenced to imprisonment.)

Kishinchand Kirplani

(He was associated with Karachi Congress and in 1932 on account of taking part in the Congress Movement he was sentenced to 2 months imprisonment

Kesomal

(He was associated with Hyderabad district Congress and in 1922 because of taking part in the Non-Cooperation Movement he was sentenced to 12 months imprisonment.)

Kewalram

(He was associated with Sukkur Congress and in 1932 on taking part in the Congress Movement he was sentenced to imprisonment.)

(He was a Khilafati worker of Shikarpur and in 1921 he was put behind the Bar .)

Moulvi Dur Muhammad "Khak":

Son of Abdul Rab Kandhiro,born in 1895 in Village Kandhira Taluka Nasirabad District larkano.Got religious education and was awrded degree of the

Moulviship.Started imparting education in Maderssahs.He was poet also.Joined Khilafat Movement in 1920 and

Muslim League in 1940.He remained

"Mubaligh"(Preacher) in both parties and created

awareness about Freedom Movement through his poetry.He breathed his last on 06.02.1981.

Moulvi Dost Muhammad:

Son of Akhund Abdul Waris Lakhmir.Born in 1875 at village Khabar Lakhmir.Got religious education and became Moulvi.Started imparting religious education in Maderssahs.Joined Khilafat Movement in 1920 and preached Freedom Movement in capacity of the “Mubaligh”of the Khilafat Tahreek.He died in 1935.

Moulvi Deen Muhammad:

Son of Gahino Khan Chandio,born in Buthi of Taluka Mirokhan.He was certified Moulvi and established his own Maderssah for imparting religious education.When Moulvi Faiz-ul-Karim of Tharoshah issued “Fatwa”(Religious Judgement) in favour of British Govt.and against of the Khilafat Movement Moulvi Deen Muhammad endorsed that Fatwa,but very soon he realized his mistake and joined Khilafat Camp and proved himself as a local leader of the Khilafat and established its branches at various villages.He also refused to accept Govt.grant for his Maderssah.He breathed his last on 15.09.1931.

Moulvi Deen Muhammad Patai:

Son of Muhammad Khan Baloch,born in 1891 at village Pat Gul Muhammad.He was awarded degree of Moulviship after completing religious education.Started imparting education in Maderssahs.He took part on Freedom Movement and for this joined Muslim League.He breathed his last on 13.04.1960.

Sadhu Hiranand:

Son of Dewan Shoukiram, born on 23.03.1863 in Hyderabad. He did Matric in 1879 and B.A in 1883. He earned position of a role-model personality in our history. He remained very active leader of the first ever Socio-political organization of Sindh-“Sindh Sabha”. He introduced the Congress in Sindh. He was a pioneer of “Barhmo samaj” in Sindh. Founded school in Hyderabad and published “Sarswati” & “Sudhar Patreeka” under his editorship. He intended to educate his daughters from reputed institution and went to Bikanir for this purpose where he breathed his last on 14.07.1893. He was one of those leaders who gave vision about the political thinking. Sadhu Hiranand influenced the social & political future of his country.

Sheikh Abdul Majeed;

Son of Dewan Lilaram, born on 7th July 1889 in Thatta. As a Hindu his name was Jethanand, he got himself converted to Islam in 1908. He started his political career as a Political Secretary to Rais Ghulam Muhammad Bhugri. He took part in Reshmi Roomal Tahreek and joined Congress in 1914. He participated in most of Annual Sessions of the all-India Congress. He earned imprisonment for many times. The Movement for the separation of Sindh from Mumbai made him diverted to Muslim League camp. This sincere and humble Freedom fighter breathed his last on 24.05.1978.
